# International Experts Group of Biosafety and Biosecurity Regulators (IEGBBR)

# **Purpose**

IEGBBR seeks to serve as an international forum where biosafety and biosecurity regulators can share lessons learned and experiences in managing high-risk research; discuss coordination of national regulatory schemes and oversight mechanisms to better align biosafety and biosecurity regulations internationally; and promote cooperation as a way to strengthen biosecurity practices globally.

## **Formation**

IEGBBR was formed in 2007.

### **Structure**

IEGBBR is composed of 11 state members, represented by their biosafety and biosecurity regulatory bodies, and two non-member observers.

Steering Committee: IEGBBR's leadership is composed of a chair, co-chair, and member, drawn from each of the three regions (Americas, Europe, and Asia-Pacific). The Steering Committee is currently chaired by Canada, with the Netherlands as co-chair and Australia as member.





# **Key Activities**

#### **Member Meetings**

The IEGBBR holds in-person meetings every two years where members share lessons learned in implementing, changing, or creating biosafety and biosecurity regulations. Members are encouraged to engage in joint-projects that lead to alignment in regulatory and oversight approaches.



#### The Compendium App

A key activity undertaken by IEGBBR was the development of the Compendium App, a free mobile-based tool that can be used to research, save, and export materials on IEGGBR members and international biosafety and biosecurity regulatory frameworks. The app provides information and references on how member countries implement biosecurity and biosafety oversight and regulatory systems. It can serve as a quick reference tool for other countries when developing or strengthening their own regulatory and oversight systems. Within the app, there are searchable fields and filters for IEGBBR member oversight systems; regulatory frameworks; processes, procedures, and records management; risk assessment requirements; compliance frameworks; accountability and personnel requirements, training, outreach, and awareness; and international agreements, conventions, and capacity-building.
